CONDITION FOR SALE

1. Subject to realization of reserve price where the same has been fixed by the North Eastern Council Secretariat, Shillong. The following vehicle shall be sold to the quotationer(s) quoting the highest rates.
2. Every quotationer(s) shall have to deposit Rs.2,000/- (Rupees Two Thousand) only as earnest money for each vehicle along with his/her quotation in the form of Account payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the commercial banks in favour of **DDO, NEC Secretariat, Shillong payable at Shillong**, which will be released to them on finalization of the sale without interest. Quotations received without earnest money will be rejected.
3. The buyer(s) has/have to deposit the full amount of the sale value only in cash with the I/c NEC Guest House, Plot No. 18, Chanakyapuri, New Delhi, within 2 (two) days of acceptance of his/her offered rate(s). if the buyer(s) fail(s) to make payment of the sale value by the stipulated date, extension, if any, to be given in the matter of the date of payment shall be the discretion of Secretary, North Eastern Council, Shillong, subject to the payment by the buyer of compensation at the rate of 0.1% of the sale value per day for the default.

In the event of failure to make payment of sale value by the buyer within the stipulated period, the proposal for the sale of such vehicle shall be cancelled, the earnest money paid therefore shall be forfeited and the vehicle may be sold to other quotationer as the Secretary, NEC, may consider best without any notice to the defaulting quotationer.

5. The vehicle will be sold on as is where basis is. However, the interested quotationer is advised to inspect the vehicle on any working day during office hours before 11th March, 2019 before offering their rates.

6. The vehicle shall remain where they are in every respect at the risk of the buyer(s) from the date of acceptance of his/her offer by the NEC and the NEC shall not be under liability for the safe custody or preservation thereof from the date onwards.

7. The vehicle shall be taken from the site where they are parked with all faults and errors in description, if any, and no warrantee or guarantee shall be implied. The North Eastern Council will issue sale release order signed by the competent/ authorized officer to the buyer on production of cash receipt issued by I/c NEC Guest House, New Delhi for the full amount of the sale value decided upon by the NEC on the basis of the valid quotations received.

8. The vehicle sold will be removed by the buyer(s) from the site where it is currently parked as early as possible (in any case, within seven days). Delivery will be made only during working hours on all working days. The purchaser(s) will make his/her own arrangements for transportation of the vehicle and he/she will not be entitled to claim any facilities from the NEC Secretariat.
