Subject: Forwarding of Inspection Report

In inviting a reference to the above subject, as requested by the concerned Sector, the physical inspection of the project "Construction of Adventure Tourism Camping cum Recreation Site at Huto Village in Doimukh, Papum- Pare District , Arunachal Pradesh" was carried out. The inspection report duly signed by the Consultant (CE), NEC, is enclosed herewith. The project was sanctioned on 11/12/2015 at a total cost of Rs. 366.60 lakhs (NEC's share is Rs. 329.94 lakhs and State's share is Rs. 36.66 lakhs). Two instalments totalling Rs. 263.96 lakhs were released by NEC.

The inspection report, inter alia, mentioned that:

- The execution of work was slow inspite of the fact that (a) NEC had released two installments amounting to Rs. 263.96 lakhs and (b) State Government had also released Rs. 36.60 lakhs which is almost 100% of State Share.
- The reinforcement used for cafeteria at site was as per specifications mentioned in DPR.
- The size of the columns and reinforcement used for the cottages was not done as per specifications mentioned in the approved DPR.
- The total costs of works not yet started come to Rs. 84, 05,405.00/- where as the balance fund to be released by NEC is only Rs. 65.98 lakhs. Hence, is bound to be a fund shortfall of Rs. 18, 07,405/-.
- The concerned Sector Head should, therefore, seek clarification from the implementing Department on how they propose to fully complete the project as per approved DPR and within the total approved cost.
- It should also be noted that the remaining time to complete the project is only three months
- NEC funding was not found to be acknowledged.

This is for information and necessary action by the concerned Sector.

(II) Aims/Objectives of the Project:- The basic objective of the project is to develop an adventure Tourism Camping cum Recreation Site at Huto Village in Doimukh, Papumpore District. The project location is the gateway to hiking, trekking and angling sites of Pare, Panior and Dikrong Valley and falls in the identified tourist circuits.

(III) Observations/ Status of works as on 07/09/2017 (Physical Achievements):-

Sl.No.	Scope of work	Amount approved by the NEC (in Rs.)	 During inspection it was found that the constructions of 2 nos of cottage were in progress. It could be seen that in one cottage the works constructed were foundation, columns, beams, ceiling slab for ground floor and erecting of columns for first floor were in progress. As for the other cottage it was found that only ground floor foundation, columns and beams had been constructed. The plinth area of the building at site was 8.6 x 16m which was 137.6 sqm. The Column size at site was 30x25cm but as per DPR it was supposed to be 30 x 30 cm and 30x35cm. The reinforcement used for columns were 4nos. of 16mm dia bar and 4 nos of 12mm dia bar. As per DPR it was supposed to be 8nos of 16mm dia bar for C1, C2, C3,C7,C10 and 10nos of 16mm dia bar for the remaining columns. It was found that the works were in progress. Foundation, columns, beams, slabs, partition wall had been constructed and plastering works were in progress. The Length of the boundary wall constructed till date was 193.7 m. The pending

(IV) Overall Remarks and Suggestions:-

During inspection it was found that the works were in progress but the execution of work was slow inspite of NEC having released two installments totaling Rs. 263.96 lakhs and the State Government having released Rs. 36.60 lakhs which is almost 100%. It could be seen that approximately 30 to 40 % of the work had been constructed for Cottages. The size of the columns and reinforcement used for the cottages was not done as per specifications mentioned in the approved DPR. As far as the cafeteria is concerned, foundation, columns, beams, slabs, partition wall had been constructed and plastering works were in progress. The reinforcement used at site was as per specifications mentioned in DPR. The construction of the retaining wall and boundary wall were in progress.

It may also kindly be noted that there are four items of work which have not yet started. Their total approved cost estimates come to Rs. 84, 05,405.00/- where as the balance fund to be released by NEC is Rs. 65.98 lakhs only. Hence, there is bound to be a fund shortfall of Rs. 18, 07,405/-. Besides, the items of work already started are yet to be fully completed. The concerned Sector Head should, therefore, seek clarification from the implementing Department on how they propose to fully complete the project as per approved DPR and within the total approved cost. It should also be noted that the remaining time to complete the project is only three months. NEC funding was not found to be acknowledged.
