#### Subject: Forwarding of Inspection Report.

In inviting a reference to the above subject, as requested by the concerned Sector, the physical inspection of the project "Construction of Outdoor Stadium in Pughoboto Sub-Divisional Headquarter, Zunheboto District, Nagaland was carried out in Nagaland. The inspection report duly signed by the Consultant (CE) and Consultant (ME), NEC is enclosed herewith. The project was sanctioned on 17/12/2014 at a total cost of Rs. 619.82 lakhs (NEC Share Rs. 557.84 Lakhs and State Share Rs. 61.98 lakhs). Two instalments totalling Rs. 373.14 lakhs were released by the NEC. Time overrun is 7 months.

The inspection, inter alia, mentioned that:

- The works were in progress despite the fact that they are behind schedule.
- The consultant had inspected the site and found that 95% of development of ground had been done.
- Photograph of land before the commencement of the project was also attached.
- For the Bays construction, it was found that the columns, beams and slab for the Bays had been completed.
- The size of the bay constructed at site was slightly more than the dimension mentioned in DPR.
- As for the Rostrum, it was found that the works for columns, beams, stair case and slab for ground floor had been completed and for first floor it was found that only columns and beams had been completed.
- The only anomaly at site was that the stair case had been constructed at the back of the Rostrum and the staff room had been shifted to a place where the stair case was supposed to be constructed.
- NEC funding was not found to be acknowledged

This is for information and necessary action by the concerned Sector which should now decide on further release of fund based on this report taking also into consideration the desirability that further time overrun has to be minimised.

The works in progress were construction of partition wall for toilets and changing rooms. The size of the bay constructed at site was slightly more than the dimension mentioned in DPR. As for the Rustrum, it was found that the work columns, beams, stair case and slab for ground floor had completed and for first floor it was found that columns and beams were completed (Photo attached). Anomaly at site was that the stair case had been constructed at the back of the Rustrum and the staff room had been shifted to a place where the stair case was supposed to be constructed. NEC funding was not found to be acknowledged.
