In inviting a reference to the above subject, as requested by the concerned Sector, the physical inspection of the project "Construction of Permanent Stage-cum- Covered Gallery at Common Festival Ground, Naharlagun, Arunachal Pradesh" was carried out in Arunachal Pradesh. The inspection report duly signed by the Consultant (CE) and Consultant (ME), NEC is enclosed herewith. The project was sanctioned on 6<sup>th</sup> February, 2013 at a total cost of Rs. 179.42 lakhs (NEC's share 161.48 Lakhs and State Share Rs. 17.94 lakhs). Two instalments totalling Rs. 129.18 lakhs were released by the NEC. Time overrun is 38 months.

The inspection, inter alia, mentioned that:

The physical progress and financial progress appear to be commensurate.

The open gallery, prayer hall cum covered gallery, stage, gate, over head tank, toilet, and compound

Since the target date of completion has already been exceeded by 36months and since the balance amount to be released by NEC Sect. is Rs. 32.30 Lakh, it is suggested that the concerned Sector may take a call on releasing another installment.

NEC funding was not found to be acknowledged.

It was seen that painting works and electrical works had been done for the whole building.</li> <li>The stage had been constructed and both painting works and electrical works have been done. The area of the stage was approximately 70sqm. The implementing department informed that the remaining 14 sqm has been added in the construction of the prayer hall cum covered gallery because it was required.</li> <li>Leveling works had been done for open space.</li> <li>It was seen that toilet had been constructed and it area was 30.62 meters. 4	Compound Wall Length 170m.	14,18,820	It was found during inspection that the compound wall had been constructed. The wall looks very dirty and paint had worn out. The implementing department informed that the painting of wall had been done long back and photos showing painting of wall was enclosed in the quarterly progress report of March 2017. The consultant has instructed the implementing department to repaint the wall before handing and taking over.

NEC funding was not found to be acknowledged, no signboard stating all the details like name of the project, cost of the project, funded by, implemented by, date of commencement of work and date of completion etc. was erected.








