#### 2. SCOPE OF WORK:

The North Eastern Council intends to dispose e-waste items as listed in Annexure-I on "AS IS WHERE IS BASIS" lying in the NEC Secretariat, Nongrim Hills, Shillong as per the Central Pollution Control Board / State Pollution Control Board guidelines for disposing of such items.

- v. No interest will be paid by this Office on the Earnest Money Deposit.

#### 5. SUBMISSION OF BIDS:

Interested parties should submit their application bid form as per format enclosed as Annexure-II on or before 26<sup>th</sup> July,2024 at 12:00 hrs. along with necessary documents in a sealed envelope superscribed with the words "BIDS FOR E-WASTE. TO BE OPENED ON 26<sup>th</sup> July,2024 "by THE ADDRESSEE ONLY" addressed to "Director (Admn.), NEC, Shillong" and drop personally in the tender box kept at Room No. 303, NEC Secretariat, Nongrim Hills, Shillong.

Any application received after the last date and time of submission will be rejected.

#### 6. CONTENTS OF THE SEALED ENVELOPE:

The sealed envelope should contain the following:-

- i. Application bid form (Annexure-II)
- ii. Self attested copy of valid registration certificate for being authorised and registered as a Dismantler / Recycler / Referbisher / Producer Responsibility Organisation of ewaste as per E-waste Management Rules, 2016 (as amended from time to time), with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the State Pollution Control Board, etc.
- iii. The Bidder must submit a notarised affidavit on non-judicial stamp paper of Rs. 50/-(Rupees fifty) declaring that the bidder was not blacklisted during the last four (4)

- years as on the date of submission of bid by State/Central Government, Government Organisations, Government Undertakings, Public Sector Undertaking.
- iv. Self attested copy of PAN Card.
- v. Self attested copy of GST registration.
- vi. In case of non-tribal bidder, a self attested copy of valid Trading License from the Khasi Hills Autonomous District Council concerned of Meghalaya. Tribal belonging to any of the Schedule Tribes pertaining to Meghalaya, will be required to submit a self attested copy of their Scheduled Tribe Certificate.

- b) If the space in the form (Annexure-II) is insufficient for furnishing full details, such information may be continued on separate sheets of paper, stating therein the part of the form and serial number. Separate sheets shall be used for each part and a proper reference with page number must be indicated in the main form of application.
- c) Clarifications, if any required, may be obtained from the Director (Admn.), NEC, Shillong during Office hours before 26<sup>th</sup> July,2024.
- d) The NEC Secretariat is at liberty to reject or accept any or all offers without assigning any reason thereof. The decision of NEC in this regard shall be final and binding. The NEC may also cancel this Notice Inviting Tender fully or partially without assigning any reason thereof and no liability, financial or otherwise, will be borne by the NEC in this regard.
- e) The inspection of the goods can be carried out by the prospective bidders or their representatives in the NEC, Nongrim Hills, Shillong 793003 in all working days of NEC between 11:AM to 4:00 PM up to 22<sup>nd</sup> July, 2024.
- f) Any taxes as levied and applicable shall be paid by the successful bidder.
- g) The e-waste items proposed will be sold "AS IS WHERE IS BASIS" and will be deemed to have been on the understanding that the bidder has satisfied fully himself/herself/ themselves in regard to the conditions, quality, etc., of the same.
- h) The successful bidder will be required to make full payment of bid by way of crossed Demand Draft/Pay Order/Banker's Cheque from any Commercial Bank in favour of "D.D.O., NEC", payable at Shillong, within 7(seven) days after issue of letter of acceptance by the North Eastern Council Secretariat on failure to do so, the Office shall have the right to forfeit the entire Earnest Money deposit amount of the bidder

and dispose the items to an alternate bidder as decided by, Secretary, NEC and will be final.

- i) The successful bidder shall be required to lift all the items to his/her premises within 7(seven) days after the payment of the quoted amount (EMD amount will be adjusted with the quoted value for the successful bidder). On failure to do so, the Office shall have the right to forfeit the entire Earnest Money Deposit amount of the bidder and dispose the items to an alternate bidder as decided by Secretary, NEC and will be final.
- j) The Successful Bidder will have to make their own arrangement at their own cost for loading and transportation of the materials/items to their respective destination. There will be whole responsibility of the Successful Bidder for any damage / mishap of labors / workers engaged during the loading of materials within the NEC Office Complex.
- k) No damage shall be caused to the property of the NEC Office Complex in the premises while removing the e-waste items. Any loss/damage to the property of the NEC or injury or personal accident suffered by any person due to negligence or action of the Successful Bidder or his authorised worker/supervisor, will be borne Successful Bidder.
- I) The Successful bidder should follow the procedure under various Laws / Acts / rules in force from time to time in connection with disposal of e-waste.
- m) No bid shall be accepted after the due date and time. If the due date happens to be a holiday, the bid shall be opened on the next working day at the same time notified as above.
- n) Bids/quotations will be opened on 26<sup>th</sup> July,2024 at 15:00 hrs. If the opening date happens to be a holiday, the bid shall be opened on the next working day at the same time at NEC Video Conference Hall, Nongrim Hills, Shillong-793003.
- o) The rate quoted should be inclusive of all taxes, miscellaneous charges like transportation, labour or any other expenses, etc.
- p) The bids shall be examined by the NEC. If more than one bidder has submitted offers, the bid comparison shall be made as per the quoted rate. The rate quoted by the bidder which is found to be the highest shall be selected by this Office provided that such rate is, in the opinion of the Office, reasonable. In case of a tie, the winning bid may be decided by draw of lots or at the discretion of the Office.
- q) In case only one bidder quotes without competition from other bidders, the Office may at its discretion select that particular bidder provided that the quoted rate is, in the opinion of the Office, reasonable.

- r) In the event of any question, dispute or difference is arising between the Office and the bidder relating to any matter arising out of or connected with this tender, the decision of Secretary, NEC shall be final and binding on both the parties.
- s) Legal jurisdiction for any disputes, if arise, is subject to exclusive jurisdiction of competent courts in Shillong (Meghalaya) only
