In inviting a reference to the above subject, as requested by the concerned Sector, the physical inspection of the project "Infrastructure Development of Omeo Kumar Das Institute of Social Change and Development, Guwahati" was carried out in Guwahati, Assam on 07/02/2018. The inspection report duly signed by the Consultant (EE), NEC is enclosed herewith. The project was sanctioned on 18 /10 /2016 at a total cost of Rs. 1133.00 lakhs (NEC's share is Rs. 1133.00 lakhs). One installment of Rs. 494.00 lakhs were released by the NEC.

The inspection, inter alia, mentioned that:

- During Inspection it could be seen that in the institute building total 45 columns already constructed only 2 nos. of column construction was pending. Foundation work for these two column not yet started.RCC wall having height of 1500 mm had been completed.
- ➢ It could be seen that columns quantity was increased from the approved approved DPR drawing, total 34 nos. of column was proposed but in the project site it was found that implementing department was executing the work from a different drawing and that drawing was having total 47 nos. of columns.
- The Works for Guest House-cum-Hostel Building not yet started.
- > The Works for constructing Internal Road had been started. Only excavation and filling had been going on.
- All the changes for the institute building were done without obtaining approval from NEC.
- Since this is an MH-"2552" project for which fund was directly released to the implementing agency, it can be said that progress of work is rather very slow. Hence, it is very unlikely that the Institute will be in a position to submit UC soon enough to facilitate release of the 2nd installment. But, first of all, due to the changes made without prior approval of NEC, clarification should be sought immediately.
- NEC funding was not found to be acknowledged.

This is for information and necessary action by the concerned Sector.

(IV) Overall Remarks and Suggestions:-

During inspection it was found it was found that in the institute building total 45 columns already constructed only 2 nos. of column construction was pending. Foundation work for these two columns not yet started. It could be seen that columns quantity was increased from the approved DPR drawing, total 34 nos. of column was proposed but in the project site it was found that implementing department was executing the work from a different drawing and that drawing was having total 47 nos. of columns. In the approved DPR ground floor plinth are was 691.00 sqm., but in project site it was found that implementing department was constructing the Institute Building which was having ground floor plinth area of around 837 sq.m. without taking necessary approval of NEC. Concerned sector may ask why these changes were made and why no approval was taken from NEC before executing the work from the implementing department. It could be seen that site was above the hillock and proper retaining wall was needed for protecting the construction. NEC funding was not found to be acknowledged in the project location , no signboard stating all the details like name of the project, cost of the project, funded by, implemented by, date of commencement of work and date of completion etc. was not erected. The officials of the implementing agency were asked to do the needful for acknowledging NEC funding.








