Inviting a reference to the above subject, the physical inspection of the project “**Construction of New Building for Girls in Nongtalang College, Nongtalang, West Jaintia Hills, Meghalaya**” has been carried out by Ms. Aarti Khyriemujat, Consultant (CE) of E&M Sector and the inspection report is enclosed herewith. The project was sanctioned on 06-01-2021 at a total cost of Rs. 110.29 Lakh. One installment of Rs. 44.11 Lakh (40% of the total approved cost), has been released by the NEC under “MH 2552” to Directorate of Higher & Technical Education, Govt. of Meghalaya..

The inspection report, inter alia, has mentioned that:

- Based on the observations made during the inspection, it can be said that the physical progress seems to **commensurate** with the financial progress.
- The works for the **Construction of New Building for Girls in Nongtalang College, Nongtalang, West Jaintia Hills, Meghalaya** is seen to be in progress, till date the progress of the construction works at site is about **~70 %**. Earthwork, structural details such as stone soling works in the plinth, reinforcement details, and concrete mix design etc **could not be checked** as works has been done at the initial stage .
- As the structure of the building is completed upto a maximum extent, shuttering works on foundations, footings, bases of columns, pile caps, rafts, beams, etc upto 1st floor level is assume to have been done. Shuttering works on a small portion of the terrace level is found at site.
- The **plinth area** of the building **~300 sqm for ground floor and ~276 sqm for 1st floor level** is more or less the **same** as that of the approved drawing in the DPR.
- The size, layout of columns (**30 nos of column in each floor and 2 nos of column for the porch area**) , staircase details is found to be more or less the same as per specification mentioned in the DPR.
- Almost **90% of the brickworks** have been done at site as is seen to be in progress.
- Wood works for placing doors and windows/ventilators has been done at site.
- Fixing of wooden doors has not yet started where fixing of steel windows/ventilators has started and is seen to be in progress.
- **Plastering works** was started from the **1st floor level** and is almost completed. Plastering works for the ground floor level and the terrace level of the building is yet to start.
- Glass works, cement coating works, application of priming coat and painting, tiling works, fixing of MS shutters and MS grills, and other miscellaneous works has not yet stated. The implementing agency informed that works is being



carried out in full swing for all the components will be completed simultaneously and is expected to be **100% completed by December 2022.**

- Regarding the aims and objective it can be said that on completion, the project will be able to increase the enrolment status of the college and eventually increase the literacy rate of females and the literacy level of the community as such college with accommodations/ hostels will be the first in the area as there was not such proper infrastructure in the past and the students had to travel miles to get to college thus there is a high percentage of college dropouts in the area..
- A signboard acknowledging NEC funding was **not found** at site.





