In inviting a reference to the above subject, as requested by the concerned Sector, the physical inspection of the project "Procurement of Equipment, Furniture & Fixture etc. For the Skill Development Centre at Ramakrishna Mission, Vivekananda Cultural Centre, Ramakrishna Mission, Quinton Road Shillong" was carried out at Shillong in the state of Meghalaya. The inspection report duly signed by the Consultant (EE), NEC is enclosed herewith. The project was sanctioned on 28/10/2016 at a total cost of Rs. 250.00 lakhs (NEC's share is Rs.250.00 lakhs).NEC released one instalments of Rs125.00lakhs (on28/10/2016).

The inspection report mentioned, inter alia, that:

- 1. The most of the items was procured but due to fund scarcity full bill was not paid to the vendors.
- 2. In approved DPR Item wise specification was not found. In the absence of item wise specifications with price, it was difficult to say if the item procured are technically up to the mark. It is also not very clear if nodal formalities have been followed in the procurement process. Implementing agency informed that due to cost deduction from the proposed DPR some deduction in material was done. Concerned Sector may ask to the implementing agency to submit specification wise material description with price which they will install according to approved DPR within project approved cost.
- 3. Inspection team could not see sign boards during the time of inspection mentioning project title, cost of the project, funded by, implemented by, date of commencement of work and date of completion etc.

This is for information and necessary action by the concerned Sector.

During inspection it was found that most of the items was procured but due to fund scarcity full bill was not paid to the vendors. In approved DPR Item wise specification was not found. In the absence of item wise specifications with price, it was difficult to say if the item procured are technically up to the mark. It is also not very clear if nodal formalities have been followed in the procurement process. Implementing agency informed that due to cost deduction from the proposed DPR some deduction in material was done. Concerned Sector may ask to the implementing agency to submit specification wise material description with cost which they will install according to approved DPR within project approved cost. NEC funding was not found to be acknowledged in the project location. No signboard stating all the details like name of the project, cost of the project, funded by, implemented by, date of commencement of work and date of completion etc. was erected. The officials of the implementing agency were asked to do the needful for acknowledging NEC funding.










