- G.S.R. 744.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the North Eastern Council Secretariat, Shillong (Group 'A' Group 'B' and Group 'D' posts) Recruitment Rules, 1983, the North Eastern Council Secretairat, Shillong (Group 'A' and Group 'B' posts) Recriutment Rules, 1984, the North Eastern Council Secretariat, Shillong (Group 'A' and Group 'B') Recriutment Rules, 1985 and the North Eastern Council Secretariat, Shillong (Group 'A' and Group 'B' posts) Recruitment Rules, 1985, in so far as they relate to the posts of Senior Technical Assistant, Assistant Engineer, Librarian (Grade I) and Senior Technical Assistant (Engineering), except as respects things done or omitted to have been come before such supersession, the President hereby markes the following rules regulating the method of recruitment to the Group 'B' posts in the Office of the North Eastern Council Secretariat, Shillong, namely :-
- 1. Short title and commencement.—(1) These rules may be called the North Eastern Council Secretariat, Shillong (Group 'B' posts) Recruitment Rules, 1987.
- (2) They shall come into force on the date of their publication in the official Gazette.
- 2. Number of posts, classification and scale of pay.—The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in column 2 to 4 of the Schedule anexed to these rules.

- 3. Method of recruitment age limit, qualifications etc.—
  The method of recruitment to the said posts, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the said Schedule.
  - 4. Disqualification.—No person—
    - (a) who has entered into or contracted a marriage with any person having a spouse living; or
    - (b) who, having a spouse living, has entered into or contracted a mariage with any person;

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may be order for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect 10 any class or category of persons.
- 6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regards.
