OFFICE MEMORANDUM

Sub.: Amendment of Recruitment Rules of the post of Director (Health) in NEC Secretariat, Shillong - reg.

The undersigned is directed to state that it is proposed to amend the Recruitment Rules of the post of Adviser (Health), NEC Secretariat, Shillong as per provisions given hereunder.

2. The draft RRs are being uploaded in NEC website for a period of 30 (thirty) days as per DoPT O.M. No. AB-14017/61/2008-Estt. (RR) dtd. 13.10.2015. All stakeholders are requested to go through the RRs and furnish their comments, if any, on the proposed amendments to the undersigned within a period of 30 (thirty) days from the date of publication of the same in the website. Amendments to RRs of the aforementioned post would be finalized after taking into account the comments received.
