- **G.S.R...-** In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the North Eastern Council Secretariat, Shillong, Executive Engineer(Power) and Research Officer(Small Scale Industries) Group 'A' Posts Recruitment Rules, 2005, in so far as they relate to the post of Research Officer (Small Scale Industries) except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Research Officer (Industries) in the North Eastern Council Secretariat, Shillong, namely:-
 - 1. Short title and commencement :- (1) These rules may be called the North Eastern Council Secretariat, Shillong, Research Officer (Industries) Group 'A' Post Recruitment Rules, 2020.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
 - 2. Application:- These rules shall apply to the posts specified in column 1 of the Schedule annexed to these rules.
 - 3. Number of posts, classification and level in pay matrix:- The number of posts, its classification, Level in the pay matrix attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
 - 4. Method of recruitment, age-limit, qualifications, etc.:- The method of recruitment to the said post, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the said Schedule.
 - 5. Disqualification:- No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax:- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Savings:- Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Schedules Castes, the Scheduled Tribes, exservicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Deputation (including Short-Term Contract):-

Officers of the Central Government or State Governments or Union Territories or Semi Government or Public Sector Undertakings or Universities or Recognized Research Institutions or Statutory or Autonomous Organisations:

- (a)(i) holding analogous post on regular basis in the parent cadre/department; or (ii) with two years' service in the grade rendered after appointment thereto on a
- regular basis in post in the pay Level-8 (Rs.47600-151100) or equivalent in the parent cadre/department; or
- (iii) with three years' service in the grade rendered after appointment thereto on a regular basis in post in the pay Level -7 (Rs.44900-142400) or equivalent in the parent cadre/department; and
- (b) possessing the following educational qualifications and experience:
- (i) Bachelor's Degree from a recognized University or equivalent.
- (ii) Three years' experience in promotion and development of industries and allied matters.

For Armed Forces Personnel-

Deputation/re-employment:

The Armed Forces Personnel of the rank of Lieutenant or equivalent who are due to retire or to be transferred to reserve within a period of one year and possessing the educational qualifications and experience prescribed for deputationists shall also be considered. If selected, such officers will be given deputation terms up to the date on which they are due for release from the Armed Forces. Thereafter they may be continued on re-employment terms. In case such eligible officers have retired or have been transferred to reserve before the actual selection to the post is made, their appointment will be on re-employment basis (re-employment up to the age of superannuation with reference to civil post).

(Period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of the Central Government, shall ordinarily not exceed three years)

The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of application.
