Subject: Forwarding of Inspection Report.

In inviting a reference to the above subject, as requested by the concerned Sector, the physical inspection of the project "Setting-up of a Seed Testing Laboratory in Meghalaya" was carried out in Meghalaya. The inspection report duly signed by the Consultant (CE), Consultant (EE) and Consultants (ME) NEC is enclosed herewith. The project was sanctioned on 23/03/2013 at a total cost of Rs. 575.42 lakhs (NEC's share is Rs. 517.88 lakhs and State share is Rs. 57.54 lakhs). Two installments totaling Rs. 410.72 lakhs were released by the NEC.

The inspection, inter alia, mentioned that:

- NEC had sanctioned the project on 23/03/2013 and the target date of completion was 2(Two) years from the date of Sanction. The Implementing department informed that progress of work was stopped for sometime i.e. after the release of the Second Installment on 20th May 2014 because the Implementing Department received the Installment from the State Government on 31st March
- In Nongstoin the civil construction work was found to be completed.
- In Nongpoh, many anomalies were found such as plinth area of the building, used of red oxide instead of marbles in stair case, wooden doors instead of PVC doors and many other anomalies as
- In Jowai, only the Structural works, brick works, plastering works completed. A lot finishing works such as painting, fixing of door windows, tiles and marbles works etc.
- > In Shillong, it was found that Implementing agency had constructed the Seed Health Test Room. The plinth area found was 6.5m.x4.65m. The painting work inside the building is still pending including wood works. The inspection team found that the entrance door was not yet fitted. Electrical wiring was found completed but implementing agency has not fitted the exhaust pipe for the generator and had installed one no. of earthing for the Generator.
- A signboard acknowledging NEC funding was not found to be erected in Jowai.
- The Project has suffered from time overrun of almost two years. Hence the progress of

The Concerned Sector should write to the Implementing Agency regarding the above mentioned points.

This is for information and necessary action by the concerned Sector.

Implementing agency stated that it was due to the collapse of a tree caused by a cyclonic storm; Implementing agency had been asked to repair the damaged portion of the wall as early as possible. Many cracks were also found in the building. At the time of inspection it was found that electrical works were completed but no proper earthing was found for the particular building so it	



	was suggested to do proper plate earthing for the smooth running of the sophisticated instruments which would be installed.

Construction of Seed Testing Laboratory. 30.5 mx12.5m (Plinth area from approved drawing)	During Inspection it was found that the Implementing Agency has constructed the Seed Health Test Room at Nongpoh, Ri-Bhoi District but the plinth area found was 27.6m.x 12.9m. It was observed that the Implementing Agency used 'red oxide pigment' on the staircase but in the approved D.P.R. Item no.26/4.25 Marble stone flooring over 20mm (average) was estimated. Inspection team found that the Implementing agency finished the flooring of entrance lobby and passage but they have used Tiles instead of marble as approved in the D.P.R, i.e, Item no.26/4.25 Marble-stone flooring over 20mm(average) was estimated.  Moreover it was also found that the Toilet doors were all wooden but in the approved D.P.R. Item no.18/18.6 and 20/18.4 P.V.C Chowkhat and Solid P.V.C Door was estimated. Inspection team noticed that cardboard-type doors were fixed to the rooms, but in the approved D.P.R. Item no.19/7/13, 38 mm thick full paneled shutter door made by Red pine Wood/local wood was estimated. Inspection team also found that the workmanship of the Gents and Ladies toilet was not done properly.  During inspection it was found that the electrical works and painting of the building was completed but by visual inspection it seemed that the Implementing Agency did not use 'Paris of Putty' of 2 mm thickness over plastered surface to prepare the surface evenly smooth as it is estimated in the approved DPR Item No. 29/4.62. Cracks were found on the wall of the Laboratory.

The plinth area found was 30.56m.x 12.54m.  During Inspection it was found that the entrance, lobby, passage and stair case were incomplete as the marble fitting works were pending. Glazed ceramic Tiles are yet to be fitted in the ADA'S Toilet, Ladies Toilet and Gent's Toilet. Plaster of Paris Putty, Plastic emulsion paint and weather shield acrylic exterior painting works have not started.  Electrical works were not completed; proper earthing for the entire building was not done properly. The earthing should have earthing chamber with covering slab, test joint and earthing strip

### (IV) Overall Remarks and Suggestions:-

NEC had sanctioned the project on 23/03/2013 and the target date of completion was 2(Two) years from the date of Sanction. The Implementing department informed that progress of work was stopped for sometime i.e. after the release of the Second Installment on 20<sup>th</sup> May 2014 because the Implementing Department received the Installment from the State Government on 31<sup>st</sup> March 2015.

.During inspection it could be seen that the Seed Health Test Room at Nongstoin, West Khasi Hills District was completed in all respect, i.e, Construction of the building, plastering, painting, installing tiles and marbles, electrification, drain construction works, putting the signboard acknowledging NEC's funding of the project, etc. Apart from Nongstoin, the Inspection team visited 3 other Seed Health Test Room constructed at Nongpoh, Ri Bhoi District, Jowai, Jaintia Hills and Shillong, East Khasi Hills District.

At Nongpoh, Ri Bhoi District, many anomalies were found, the plinth area found was 27.6m.x 12.9m which differs from the actual plinth area i.e. 30.5m x 12.5m. It was seen that the Implementing Agency used red oxide pigment on the staircase but in the approved D.P.R. Item no.26/4.25 Marble stone flooring over 20mm (average) was estimated. Inspection team also found that the Implementing Agency used tiles for the flooring of the entrance lobby and passage but in the approved D.P.R. Item no.26/4.25 Marble stone flooring over 20mm (average) was estimated. Moreover it was found that Toilet doors were all wooden but in the approved D.P.R. Item no.18/18.6 and 20/18.4 P.V.C Chowkhat and Solid P.V.C Door was estimated. Apart from this, the Inspection team noticed that the doors to the other rooms were of cardboard-type but in the approved D.P.R. Item no.19/7.13, 38 mm thick full paneled shutter door made of Red pine Wood/local wood was estimated. The workmanship for the gents and ladies Toilet were not properly constructed. Many Cracks were found in the building. The Inspection Team found that electrical works and painting of the building were completed but through visual inspection it seemed that the implementing agency did not apply Paris of Putty of 2 mm thickness over plastered surface to smooth out the surface as was estimated in the approved DPR Item No. 29/4.62.

On inspecting the Seed Health Test Room at Jowai, Jaintia Hills, the following observations were made. The plinth area was found 30.56m.x 12.54m. The marble fitting works at the entrance lobby, passage and stair case have not started. Glazed ceramic Tiles are yet to be fitted in the ADA's Toilet, Ladies Toilet and Gent's Toilet. Plaster of Paris Putty, Plastic emulsion paint, weather shield acrylic exterior painting works have not started. Electrical



works were incomplete and proper earthing for the entire building was not done properly. The earthing should have earthing chamber with covering slab, test joint and earthing strip.

In Shillong, it was found that Implementing agency had constructed the Seed Health Test Room. The plinth area found was 6.5m.x4.65m. The painting work inside the building is still pending including wood works. The inspection team found that the entrance door was not yet fitted. Electrical wiring was found completed but implementing agency has not fitted the exhaust pipe for the generator and had installed one no. of earthing for the Generator.

It was observed that the construction of some of the above mentioned sites differ from the original DPR, therefore it was instructed that before any changes could be made, the Implementing Agency should seek approval from NEC. As for the machineries and equipments, it could be seen that few of the items were procured while some were still left to be obtained by the respective Laboratories. NEC funding was not found to be acknowledged at Jowai; therefore the Implementing agency was asked to do the needful.




































