

1. Anti Erosion measures to protect village Uma Nagar upstream and its adjoining area from the erosion of river Gangia, Kokrajhar, Assam





The project was sanctioned during the year 2020-21 at an estimated cost of Rs. 450.00 lakh. NEC has released an amount of Rs. 362.00 lakh. The project involves anti-erosion measures in the form of apron in cage and bank pitching in cage to protect Uma Nagar village upstream and its adjoining areas from the erosion of river Gangia. The project has yielded tangible benefits for the local populace residing along the banks of River Gangia. The implementation of anti-erosion measures has not only protected the community from the threat of floods but has also effectively mitigated the erosion of land. The project will benefit an area of 1250 Ha and 3 no. of villages with a population of 30,000 nos. The physical progress of work is 100%.

 2. Anti Erosion measures to protect BB of river Darranga at different reaches, Baksa district. Assam






The project was sanctioned during the year 2020-21 at an estimated cost of Rs. 495.73 lakh. NEC has released an amount of Rs. 437.27 lakh. In order to prevent flood and erosion problems in the Darranga area at different reaches, anti-erosion measures in the form of boulder filled apron in cage and bank pitching have been provided. On completion, the project will benefit an area of 2500 Ha and a population of about 50,000 nos in 8 villages. The physical progress of work is 100%.

3. Construction of land protection work at Siang river to protect Sigar, Motum,

Borguli and Seram village, Arunachal Pradesh.





The project was sanctioned during the year 2021-22 at an estimated cost of Rs. 346.53 lakh. NEC has released its entire share in two instalments. The project involves construction Gabion walls/ structures to protect the affected villages of Sigar, Motum, Borguli and Seram under Mebo Block from continuous erosion from the flush flood waters of the river Siang. The physical progress of work is 100%.
